# 13 Any other business

Consideration was given to a motion from Neil Graham, in advance of the MCCU meeting. It was considered that the motion would have the committees support.

Consideration was then given to the ECF proposal to raise membership fees. This was debated between the committee. Although it is recognised that the membership fees help to fund national teams, and this in itself can give rise to greater recognition for chess, the EC voted 5-2 against the increase in ECF subscriptions.

Further proposals from the ECF relate to proposals to ensure that each county team has at least one female player. This was debated. Although it was recognised more female players would be welcome, it was considered that counties may struggle to find the female players at each level. This could not therefore be supported.
