# 5. Season 22/23

Meeting held on the 21<sup>st</sup> July 2022.

Considered way forward. Variety of issues seen still for clubs - lack of drivers/covid/ venues.

Was indicated Mansfield had 7 players only. So 5 in division one would have assisted them.

40 teams of 5 pre covid, 30 of 4 last year. Indicated that the Gambit website had some statistics on players from last year.

### a. Proposal by the EC

Proposal that the LMC be once again allowed to vary some league rules for season 22-23 due to the on-going effects of Covid.

Following the postponement of the AGM on 18 July due to the exceptional heat conditions, the LMC still needed to take the view of clubs on their recommended temporary rule alterations for the 22-23 season in order to get on with organising the new season. This was done at a zoom meeting on the 21 July and the decisions have been notified to all clubs.

Having taken this practical measure, this proposal is simply to ratify the above, without which the start of the season would have been significantly delayed.

Looking forward, at the end of this new season, the EC view is that we will either return to the full league rules, or formally amend these at a normal Rules Revision Meeting as the association deems necessary.

There was Discussion around the eligibility rule and whether this will be abused. Grading played havoc last year as lots of players without grades or high grade after only few games. Indicated there will be promotion/ relegation this year. Next year it is intended either go back to old rules or consideration will be given to changing them at a Rules Revision meeting.
